They teach about what to expect as the disease progresses and help the patient and family prepare for what may happen in the future.

Could you or someone you love benefit from this service? Supportive Care may benefit people who:

- are struggling with symptoms from serious illnesses such as cancer; diseases of the heart, liver, kidneys or lungs; MS, Parkinson's disease, ALS, stroke and dementia);
- have trouble leaving the home due to their symptoms;
- have had repeat hospitalizations or emergency room visits due to unmanaged symptoms; or
- would benefit from discussing goals of care and what's important to them.

Medicare, Medicaid and most insurers usually cover Supportive Care consultations and follow-up visits. You may have a co-payment. If you do not have insurance and cannot pay for the consultation, Agrace may be able to offer you help paying, through its Care for All program.
